

# Privacy Policy

---

This Privacy Policy ("Policy") applies to <https://mvelectric.co>, and Mountain View Electric LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include <https://mvelectric.co>. The Company's website is a services or service requests site. By using the Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

---

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Email address
- Phone number
- The details about the electrical services needed

The Company may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us.

However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include:

- Registering for an account
- Entering a sweepstakes or contest sponsored by us or one of our partners
- Signing up for special offers from selected third parties
- Sending us an email message
- Submitting your credit card or other payment information when ordering and purchasing products and services.

To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

---

The Company collects and uses your personal information in the following ways:

- To operate and deliver the services you have requested
- To provide you with information, products, or services that you request from us
- To provide you with notices about your account
- To carry out the Company's obligations and enforce our rights arising from any contracts entered
- To notify you about changes to our <https://mvelectric.co> or any products or services we offer
- In any other way we may describe when you provide the information
- For any other purpose with your consent.

The Company may also use your personally identifiable information to inform you of other products or services available from the Company and its affiliates.

## Sharing Information with Third Parties

---

The Company does not sell, rent, or lease its customer lists to third parties.

The Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. ## Tracking User Behavior

---

## Automatically Collected Information

---

The Company may automatically collect information about your computer hardware and software. ## Use of Cookies

---

The Company's website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
